Context and objectives of the conference:

What role can civil society play in times when citizens feel helpless in the face of current crises and the threat of their cumulative effects?

The Russian war in Ukraine, the refugee and migrant waves into Europe, the rising energy and food prices, climate change and political proposals to address it, the Covid-19 pandemic, are just some of the headlines of recent years. Alongside them, we can observe in the public space a growing support for behaviour and actions that adversely affect the democratic environment and break down social cohesion.

Only cooperation between the state and civil society, the private and academic sectors can provide comprehensive and functional solutions to such challenges. A vibrant civil society is an important pillar of democracy. With its practical and community-based perspective and know-how, it contributes - together with the perspective and know-how from the private and academic spheres - to the higher quality and relevance of public policies. High quality and relevant public policies enhance good governance and strengthen trust in the state and thus democracy. Conversely, poor quality and irrelevant public policies lead to increased frustration in society, a decline in trust in public institutions, erosion of democracy, the rule of law and social cohesion, and strengthen the electoral base of populist and extremist parties.

The aim of the conference on the Strategic Partnerships for Building Democratic Society in Europe is to:

- to promote **dialogue and cooperation** between representatives of public administration, parliament, NGOs and other actors in the Czech Republic and the EU.
- To present, through concrete examples, the **principles of partnership and the benefits of cooperation between public administration and civil society** and NGOs in addressing crises and societal needs.
- link the need for **democracy building in Europe with support for a resilient civil society** and the creation of favourable conditions for its activities.
- contribute to a successful Czech Presidency of the Council of the European Union.
